- **The pagination of the bundle must correspond exactly with the page numbers on Caselines.**
- **Heads of argument, practice notes (including list of authorities and chronology) & draft orders separate from pleadings – sub-heading(s)**

The bundle must be delivered **on or before 12:00 on Thursday, 12 February 2026.**

- Parties may introduce themselves on the date of the hearing of their matters in court.
- Parties must attend on the hearing date and time as indicated below.
- All draft order must indicate the date of hearing, the court room, the Acting Judge's name, the correct names of the parties, correct case number, number on roll as well as the names of the parties' legal representatives (at the bottom).
- Legal practitioners are advised to check the day roll for the court room.
- Matters not uploaded on Caselines will be removed from the roll.
