1. Kindly find hereunder the Family Court roll for matters before Wagener AJ.
2. All unopposed divorces (matters 1 to 17 on the appended roll) are allocated to be heard on Monday, 22 June 2026, from 10h00. Matters in which viva voce evidence is required will be disposed of first.
3. All other unopposed matters (matters 18 and 23 to 27 on the appended roll) are allocated to be heard on Monday, 22 June 2026, from 11h30.
4. Unless otherwise advised, all opposed matters (matters 19 to 22 on the appended roll) are allocated to be heard on Tuesday, 23 June 2026, from 10h00.
5. Unless otherwise advised, all urgent matters are allocated to be heard on Wednesday, 24 June 2026, from 10h00.
6. All matters are to be heard in open court, as indicated on the day roll concerned. Introductions will be done as counsel call their matters.
7. Matters may be called in order of seniority.
8. Matters must comply strictly with the Amended Family Court Directive dated 4 February 2026. Non-compliance with the relevant paragraphs of the said Court Directive may result in the matter being struck from the roll.

9. One hard copy of all draft orders must be handed up at the hearing and uploaded to CaseLines and must include the date, the presiding judge's name (S. D. Wagener AJ), the prescribed disclaimer and the particulars of the attorney of record and the counsel/attorney appearing.
10. Draft orders must be signature-ready and must not contain the words "*draft*" or "*further and/or alternative relief*". Where applicable, the settlement agreement must accompany the draft order or be handed up with it.
11. Witnesses must be suitably dressed.
