TO: ALL LEGAL PRACTITIONERS

DIRECTIVES

1. Kindly note that all family court matters which will be heard in the week of **31 AUGUST to 4 SEPTEMBER 2026** will be heard in **Open Court** at **10h00 unless otherwise directed**.

(Details of the court allocated should be checked on the day roll)

2. Strict compliance with Practice Directive 1 of 2024 as well as the general Family Court Directives are required. The papers must be timeously accessible on Caselines. The failure to comply with paragraphs 7.5 and 7.6

of Practice Directive 1 of 2024 may result in the matter not being heard.

3. Matters are allocated as per the roll set out hereunder.
4. Plaintiffs in unopposed divorce matters as a general rule, are not required to appear in person in which case, an uploaded evidence affidavit will suffice. However, should no evidence affidavit be uploaded alternatively, if the Family Advocate has not endorsed the settlement agreement and/or raised a query, the Plaintiff **MUST** be ready to testify.
5. All parties testifying **MUST** be suitably dressed for Court.
6. Parties must ensure that a case profile is created for their matter on CaseLines and all relevant documents must be uploaded thereon before **12h00 on the Thursday, before the week in which your matter is enrolled.**

No further papers will be considered after 12h00 on that Thursday, nor are documents to be uploaded without the Judge's leave.

7. If a **draft order** is to be made an order of court, **one hard copy** must be brought to be handed up in court.
 - 7.1. **Draft Orders and settlement agreements**, if applicable, must correctly indicate the Judge's name (i.e. MADAM ACTING JUSTICE FOURIE), date on which the matter was heard, in which court, and at the end of the draft order the party must indicate the name and contact details of their counsel and their instructing attorney. Please remove the paragraph "*Further and/or alternative relief*" and the word "*Draft*" in the tram lines.
 - 7.2. The pages must be numbered and bound with a staple.
8. Introductions to Acting Judge Fourie shall take place at **09h30. Please note that Acting Judge Fourie's chambers are situate in office 21 at the Palace of Justice.**

9. Matters that have become settled, are to be postponed or removed from the roll and should be communicated to Ms Ndulini by e-mail to NNdulini@judiciary.org.za as soon as reasonably possible.
