1. Kindly take note that there will be no virtual court appearances. All matters will be dealt with in an open court (Please confirm the court room on the daily roll) and introduction will be conducted every morning at chamber 5.5 at 09H45
2. Kindly be advised that Judge Holland-Muter requests all parties submit the heads of arguments and practice note to Chamber 5.5 not later than 28 August 2026 before 14:H00, your cooperation in this regard will be appreciated.
3. Parties should ensure that their heads of argument, joint practice notes exhibits and all pleadings are filed on Case lines no later than 28 August 2026. Practice notes should set out, among others, legal practitioners' contact details (names, email addresses and contact numbers), issues requiring determination,

relevant portions of the papers to be read, common cause facts relevant to the relief sought in the pleadings and the estimated duration of the hearing. A hard copy of draft order should be available for the court before the matter commences.

4. Parties should ensure compliance with the relevant directives pertaining to delivery and uploading of both parties' Heads of Argument and court orders obtained through an application to Compel.
5. Kindly take further note that the uploading of documents on Case lines outside the stipulated times and without condonation will result in the matter being struck off the roll and costs *de bonis propriis* may be ordered against the errant practitioner.
6. Parties should upload proposed draft orders onto Case lines in word format. Draft orders should contain a disclaimer, indicating date of hearing, Judge's name (i.e Holland-Muter J), manner of hearing (Open court) and the name and details of Counsel/Practitioner and those of the instructing attorney.
7. Counsel/Practitioners appearing in an open court should be robed. Counsel /Practitioners not addressing the court should always maintain the decorum of the court at all times.
8. Notices of removals, postponements, settlements should be uploaded on Case lines or send to Mmmampa@judiciary.org.za by no later than 28 August 2026. Kindly take note that practitioners will only be required to appear on the specific day and time allocated for the day in question.
