1. Matters will be conducted in **OPEN COURT** at 10:00.
2. Introductions will be done in **OPEN COURT**.
3. Roll call will be held on **MONDAY, THE 31<sup>ST</sup> OF AUGUST 2026**, at 10:00
4. The parties are directed to liaise with one another and advise the Judge's Secretary, by no later than **FRIDAY, THE 28<sup>TH</sup> OF AUGUST 2025, 10h00**, of their mutually agreed preferred date for the hearing.
5. Parties should ensure that the Heads of Argument and Joint Practice Notes are filed on CaseLines no later than **FRIDAY, 28 AUGUST 2026, 10h00**. Practice Notes should set out, amongst other things, legal practitioner's contact details (names, email addresses and contact numbers), issues required for determination, relevant portions of the papers to be read, common cause facts relevant to the relief sought in the pleadings and the estimated duration of the hearing. A hard copy of the Heads of argument and draft order to be made available for the court before the matter commences. Parties should ensure compliance with the relevant directives pertaining to the delivery and uploading of both parties' Heads of argument and court orders obtained through an application to compel.

6. Kindly take further notice that the uploading of documents on CaseLines outside the stipulated times and without condonation will result in the matter being struck off the roll and costs *de bonis propriis* may be ordered against the errant practitioner.
