DIRECTIVE FOR URGENT COURT BEFORE HON. COLLIS (J) WEEK 5, 18 – 21 AUGUST 2026.

This is the Directive for the Urgent Court proceedings commencing on the 18th of August 2026.

1. Kindly take note that there will only be open Court appearances, in light of the Judge President's Directive No.1 of 2025 dated 26 February 2025. Court proceedings will commence at 10h00. A final roll will be published with individual time slots on TUESDAY 18 AUGUST 2026 on or before 16h00.
2. All practitioners are required to appear in open Court on 18 August 2026. Kindly refer to the Day Roll for the allocated Court.
3. All in person litigants should come to office 5.8 for assistance.

4. On 18 August 2026, introductions will take place at 09:45 a.m. in Chambers 5.10.
5. If cases were not ready by close of roll Thursday 13th August 2026, (i.e. all relevant affidavits filed and the cases to be indexed and paginated), they will not be heard, unless there exist good cause or exceptional circumstances.
6. All cases must be uploaded on Caselines. If any problems are experienced, the Judge's Secretary should be contacted timeously for assistance.
7. A practice note must be filed on Caselines setting out the following:
 - (a) The grounds for urgency;
 - (b) The nature of the application;
 - (c) The estimated duration of the matter;
 - (d) If there is non-compliance with the JP's directives issued for the urgent court, the reasons for such deviation must be stipulated;
 - (e) Parties should ensure that a compliance declaration is uploaded onto Caselines; and
 - (f) Contact details of the legal practitioners, which must include both cellphone numbers and email addresses.
8. Where no Practice Note has been filed by 14 August 2026 at 16h00 the matter will be struck from the roll unless good cause is shown for non-compliance as per this issued Directive.

9. Matters that are to be removed, postponed, or which have become settled – Draft orders should be uploaded in both PDF and WORD format and are to be emailed to LNkosi@judiciary.org.za/lungelonkosi9@gmail.com no later than Monday 17 August 2026 at 16h00.

10. Draft orders should contain a Disclaimer, indicating the date of hearing, Judges' names (i.e. Collis J), manner of hearing (Open Court/Virtual) and the name and details of Counsel/Practitioner and those of the instructing attorney. See below disclaimer to be inserted.

DISCLAIMER: "This Order is made an Order of Court by the Judge whose name is reflected hereon, duly stamped by the Registrar of the Court and is submitted electronically to the parties or their legal representatives by e-mail. This Order is further uploaded to the electronic file of this matter on Caselines by the Judge or his/her Judges Secretary. The date of this Order is deemed to be ____."

11. In all opposed matters, Heads of Argument are to be filed by both parties by no later than Saturday 15 August 2026 at 16h00. Strict adherence will be enforced on the grounds of urgency.

12. There will be no piece-meal filing of affidavits that will be permitted.

13. If there is non-compliance with this Practice Directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.

14. Please be aware that allocation does not mean that the matter is considered sufficiently urgent to be heard on the merits. Submissions will still need to be made regarding the grounds of urgency at the hearing.
