2. The court roll will be as it appears herein.
3. All **Unopposed insolvency** matters will be dealt with on **Tuesday, 28 July 2026**.
4. All **Opposed insolvency** matters will be dealt with on the date and time indicated on the roll below.
5. **Hard copy bundles for all opposed matters should be delivered to Brooklyn Bridge Office Park, 570 Fehrsen Street by Thursday, 23 July 2026.**

6. Allocated opposed matters which are not proceeding can be mentioned on Monday 27 July 2026 and parties need not wait for the allocated day and time.
7. All matters which become opposed will be allocated to a specific date in the week 27-31 July 2026. The allocation will be done on 27 July 2026 in open court.
8. The Judge must be alerted as soon as a matter becomes opposed. Should the parties agree on a specific date for argument, same may be requested in a Practice Note to be filed by counsel.
9. Matters that become settled, removed or postponed by agreement must be communicated by e-mail to Ms. Tshepang Mpuru at [TsMpuru@judiciary.org.za](mailto:TsMpuru@judiciary.org.za) without delay.
10. Draft Orders on CaseLines must indicate the words "Draft Order", however, Counsel are advised to hand over one copy to court with words "Court Order".
11. Parties must ensure that their matters which do not currently appear on CaseLines **(highlighted in red)** are uploaded and properly reflect on the system by no later than **Wednesday, 22 July 2026, 16:00**.
12. A Practice Note must be filed setting out the date of allocation of the insolvency matter and particulars and contact details of the legal representatives (in addition to compliance with the Directive on practice notes).
13. Practice Notes (original or supplementary) are to be uploaded by no later than **16:00** one **full court day** before the date of set-down.

14. The uploading of the matter must be done in line with the Practice Directives, stipulating each item under a specific heading. Practice Notes are to be uploaded under the heading "Practice Notes".
15. For opposed matters, parties must upload **Comprehensive Practice Notes** and **Comprehensive Heads of Argument**.
16. Legal practitioners must before uploading the Draft Orders on Caselines, ensure that the draft order contains the correct case number, correct names of the parties involved, that the application appeared before **THE HONOURABLE ACTING JUDGE J KAMFFER** on the applicable set down date and that the matter was heard at a specific court and include the following Disclaimer:
- This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email.
