DIRECTIVES

Opposed Motions Directives and Roll **Before the Honourable MADAM ACTING JUSTICE CHABEDI** **8 - 12 JUNE 2026**

1. This is the main directive for matters which will be heard in the week of the **8 to 12 June 2026 by Madam Acting Justice Chabedi**.
2. Non-compliance with this practice directive, may result in the matter being struck from the roll, unless good cause is shown for non-compliance.
3. Heads of argument and practice notes must have been filed **by 15h00 Friday, 5 June 2026**.
4. A **JOINT PRACTICE NOTE** (where applicable) must be filed on Caselines on or before **15h00 on Friday, 5 June 2026** setting out the following:
 - 5.1. particulars and contact details of the legal practitioners;
 - 5.2. nature of the relief sought;
 - 5.3. a brief summary of the factual and legal issues involved;
 - 5.4. summary of the respective parties' argument;

- 5.5. indication of the portions of the papers that must be read and which not; and
- 5.6. any matter for the Judge's special noting.
- 5. Draft **orders in word format are to be uploaded on Caselines and emailed to the presiding Judges' secretary** by no later than **15h00 on Friday, 5 June 2026**.
- 6. Where matters are removed from the roll, a **notice of removal** must be uploaded onto Caselines and sent via email to the presiding Judges' secretary as soon as possible.
