1. HEARING:

1.1 All matters will be heard in **OPEN COURT** at **10:00**

1.2 Introductions will be done in **OPEN COURT** as and when counsel call their matters.

1.3 No documents may be uploaded onto Caselines after **FRIDAY, 07 AUGUST 2026**.

1.4 Parties must bring one hard copy of the draft order sought to hand up. The draft order should contain the date, court and name of the Judge, as well as the name and contact details of the party's counsel and instructing attorney – the draft order should also contain the certificate regarding electronic uploading thereof.

1.5 All matters must comply strictly with these directives and the Consolidated Practice Directives.

2. UNOPPOSED DIVORCES

2.1 All unopposed divorces will be heard on **TUESDAY, 11 AUGUST 2026**.

2.2 Divorces where there are settlement agreements and no minor children, may be called and finalised on the documentary evidence and evidence affidavits, provided that all documents are uploaded to Caselines and all relevant information is properly before court by **FRIDAY, 07 AUGUST 2026**.

2.3 All unopposed divorces with no settlement agreements will be dealt with by way of viva voce evidence.

2.4 In unopposed divorces, where minor children are involved, settlement agreements must be endorsed by the office of the Family Advocate and viva voce evidence needs to be led.

3. **URGENT MATTERS.**

3.1 Urgent matters will be heard on **WEDNESDAY, 12 AUGUST 2026 at 10:00**.

4. **OTHER FAMILY MATTERS:**

4.1 All other family matters (**including RULE 43 APPLICATIONS**) will be heard on **THURSDAY, 13 AUGUST 2026** or at a later date and time as required by the exigencies.

4.2 Counsel is requested to have regard to the widely shared note function on CaseLines as queries may be raised and/or notes may be distributed using this function prior to the hearing date.
