6. Practice notes, if not filed, must be filed no later than **16h00 on Friday 20 March 2026**, stating the nature of the application, the issues to be decided, the pages that should be read and the estimated duration.
7. Draft orders indicating the name and particulars of the Judge, together with all further necessary details, must be filed by no later than **16h00 on Friday 20 March 2026** for consideration. Draft orders should also include the following:

“This order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on CaseLines by the Judge or his/her secretary. The date of this Order is deemed to be the date of hearing of the matter. “

8. A draft order (in duplicate) is to be handed up in court at the hearing of the relevant matter.
9. Heads of argument must be filed in all opposed matters (including urgent applications) by 16h00 on Friday 20 March 2026
10. No further documents may be uploaded on CaseLines after 16h00 on Friday 20 March 2026. Matters not reflected on CaseLines by this date and time, will be removed from the roll.
