5. All Opposed insolvency matters will be dealt with on the date indicated on the roll below.
6. Matters that become settled, removed or postponed by agreement must be communicated by e-mail to Ms. Thembisile Dlamini at DlaminiT@judiciary.org.za without delay.
7. The uploading of each matter must be done in line with the Practice Directives, stipulating each item under a specific heading. Practice Notes are to be uploaded under the heading "Practice Notes".
8. For opposed matters, parties must upload Comprehensive Practice Notes and Comprehensive Heads of Argument.
9. The Practice Notes and all pleadings for both opposed and unopposed matters must be uploaded on caselines by close of business on **Wednesday, 26 August 2026**.

10. In both opposed and unopposed matters one hard copy of the draft order is to be handed up on the day of hearing. Parties are to ensure that the case details, courtroom, and Judges details are correct on the draft order.
11. It is the responsibility of the applicant's attorney to ensure that the matter is TIMEOUSLY, PROPERLY AND FULLY uploaded onto Caselines and that the Judge and her clerk will have access to the matter to enable the Judge to read the papers. Late filing or updates will not be accepted.
