2. Court will commence at 10:00. The Court Room will be confirmed on the day roll.
3. Introductions will take place as from 09:45 in the judge's chamber.
4. The allocations are as follows:
 - (a) All unopposed matters will be heard on Monday, 21 September 2026 at 10:00;
 - (b) All urgent matters will be heard on Tuesday, 22 September 2026 at 10:00, unless allocated for hearing to later in the week. The urgent roll and its

allocations will be made available after the urgent roll has closed.

5. All Counsel are required to appear in all the matters that they hold briefs in, subject to paragraph 5 below.
