4. All relevant documents are to be uploaded and accessible to CaseLines no later than 14:00 2 court days prior to the date of the hearing
5. All matters MUST have a Practice Note. Practice notes must be uploaded by no later than 12:00 on Friday, 28 August 2026;
6. Counsel is required to provide a draft order in hard copy format to the judge on the day of the hearing which draft order should contain the correct particulars in all respects. If all documents are not filed, the matter will be Removed from the Roll.
7. The draft order uploaded onto CaseLines must mirror the hard copy of the draft order handed up to the judge.
8. All draft order should contain the following paragraph:
