6. The matters will be called in order of seniority Counsel.

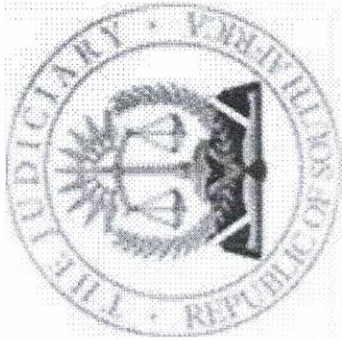
