Practitioners' attention is drawn to the content of paragraph 8 of the 10 March 2025 Notice regarding the introduction of Insolvency Court, from the Office of the Deputy Judge President, as attached to this mail. (DIRECTIVE: Rules for the dedicated Insolvency Motion Court (IMC) and the dedicated Insolvency Court (ITC) in the Johannesburg High Court).
5. Paragraph 8 states that the above mentioned Directive prevails over the provisions in Directive 1 of 2024 regarding enrolment of opposed applications.
