Where matters have **already** become defended or settled prior to the hearing, the parties are to inform the Judge's secretary of this fact immediately by e-mail (RBudeli@judiciary.org.za) thereafter, upload a draft order, and bring a hard copy of the draft order to court should they wish the matter to be removed. This will avoid unnecessary perusal and preparation.
5. The removals, postponements and settlement of matters will be heard at the calling of the roll; whereafter matters will be heard in order of seniority.
6. Draft Orders on CaseLines must indicate the words "Draft Order", however, Counsel are advised to hand over one copy to court with words "Court Order".
7. Practice Notes are to be uploaded by no later than **16h00** on **full court day** before the date of set-down.
8. The details of a representative from the State Attorney or claims handler (where not defended) and the link number must be indicated on the last page of the draft order.
