**DIRECTIVES FOR UNOPPOSED MOTIONS ROLL BEFORE THE HONOURABLE

AUGUST 2026**

1. Matters will be heard **in open court** commencing at 10:00. The Court in which the matters will be heard will appear on the Day Roll.
2. All documents are to be uploaded to Caselines at least two full court days before hearing.
3. Notice of Motion, Founding Affidavit, Notice of set down, Return/s of Service, Practice notes, and a draft order must be uploaded to Caselines under a same section for ease of access.
4. Where matters have **already become defended or settled prior to the hearing**, the parties are to inform Mr. Rothemba Budeli of this fact immediately by e-mail to

(RBudeli@judiciary.org.za) thereafter, upload a draft order, and bring a hard copy of the draft order to court should they wish the matter to be removed. This will avoid unnecessary perusal and preparation.

5. One hard copy of the draft order is to be handed up on the day of hearing. Parties are to ensure that the case details, courtroom, and Judges' details are correct in the draft order.
6. Draft orders to be handed to court should bear the words 'Court Order' and not a 'Draft Order'.
7. Standing down of matters will not be allowed.
8. No document must be uploaded on caselines one day before hearing or on the date of hearing without the permission of the Judge.
9. Failure to comply with this mandatory directive may result in the matter being removed from the roll.
