3. Legal practitioners must ensure that all matters which do not currently appear on caselines are uploaded and properly reflected on the system by no later than 22 May 2026 close of business.
4. Legal practitioners must further ensure that all document or bundles which do not currently appear on caselines are uploaded and properly reflected on the system by no later than 22 May 2026 close of business.
5. Introductions will take place at office 2 (Palace of the Justice) at 09h45.

6. Legal practitioners must hand in only one copy of the draft order in court. The draft order must contain date of hearing, court room ,correct matter number and the Judge's surname (**Madam Justice Janse Van Nieuwenhuizen**).
7. Legal practitioners must before handing in the draft order in court, ensure that the draft order contains the correct case number, correct name of the parties and if there's any amendment made by manual script, such amendment must be initialled or signed by the legal practitioner.
8. The court will not deal with matters that were not placed timeously, if your matter was properly enrolled but does not appear on this roll, please contact or approach the enrollment office.
9. Please note that court orders will be stamped, signed and uploaded within 7 court days.
