2. APPEARANCE & REMOVAL NOTICE

(a) Appearance will be required in all matters, save for those that had duly been removed by notice.

(b) Removal notice(s) must, thus, be accordingly uploaded, failing which, counsel is expected to appear in the matter.

3. ACCESS/ INTERFACE BUNDLE/ PRACTICE NOTE(S)

(a) Parties are to ensure that:

(i) all of their matters are accessible on Caselines by both the presiding Judge and his/her Registrar, including those that were initiated and interfaced from Court-OnLine;
