The practice note must clearly indicate which sections of CaseLines are to be read.
7. Parties (both Applicants and Respondents) should upload on CaseLines proposed draft orders in Word format at least the day before a particular matter will be heard. Two hard copies must be available at the date of hearing as well.
8. In the event that matters are to be removed, postponed or become settled, the parties must email notices to this effect without delay to Ms Aseza Gubela – AGubela@judiciary.org.za and make a widely shared note on CaseLines to that effect.
