1. There will be no open court appearances, the matters will be heard via MS Teams. The daily links will be posted as a 'wide access note' on Caseline.
2. The hearings will start from Tuesday, 11 August 2026 as per the date and time allocated roll appearing below. Legal Practitioners are directed to log on to the MS Teams virtual hearings at least 15min before the indicated timeslots in order to resolve any technical issue that may arise.
