DIRECTIVE: SPECIAL INTERLOCUTORY COURT (TRIAL INTERLOCUTORY ROLL)

3 - 6 AUGUST 2026 - BEFORE THE HONOURABLE MABUDA AJ

1. This directive, read with paragraph 27 of the Revised Consolidated Practice Directive 1 of 2024 ("RCPD"), applies to all matters on the Trial Interlocutory Rolls of 3 to 6 August 2026, published herewith.
 2. The Court sits at **10h00 each day** at the Johannesburg High Court, in a court number to be confirmed by the Judge's secretary. Matters are called in the order of the roll, but the Judge may vary the order and take settled and unopposed matters first. **Appearance is in person.** A request to appear by video-link must be made promptly in the practice note and state whether all parties agree.

3. **By 14h00 on the court day before the hearing** (for Monday 3 August 2026, **by 14h00 on Friday 31 July 2026**) (“the deadline”), the enrolling party must ensure that the matter is on CaseLines and the Judge's secretary invited. In matters marked “NOT ON CASELINES”, the complete papers, proof of service and draft order must be uploaded.
4. Once the matter has been made available on CaseLines, the parties must **advise the Judge's secretary by email** that the matter is now accessible, so that the invitation can be extended. If the matter is not on CaseLines by the deadline, it will be **struck from the roll**, unless the Judge directs otherwise.
5. By the deadline, the **draft order must be emailed in Word** to the Judge's secretary, with the names and email addresses of counsel and the attorney. A hard copy of the draft order is handed up at the hearing (RCPD para 27.9).
6. By the deadline, a short **practice note must be uploaded and emailed**, stating the relief sought, whether the matter is opposed, settled or to be removed, and a time estimate.
7. Opposition **will not, of itself, postpone a matter**. Opposed applications will ordinarily be decided during the week. In opposed matters, brief **heads of argument of no more than five pages** are due by the deadline (RCPD paras 27.8 and 27.10).
8. The Court **will not hear an application to compel attendance at a pre-trial conference** unless the matter has been **referred to the registrar under rule 37(3)(b)**, save in exceptional circumstances (RCPD para 27.14).
9. Settlements, withdrawals and removals must be reported to the Judge's secretary **by email immediately**. In matters marked “MEDIATION”, practitioners must be ready to report on the status of the mediation or referral.
10. Non-compliance may result in the matter being **struck from the roll**. It may also attract punitive costs, including disallowing practitioners' fees, and referral to the Legal Practice Council (RCPD paras 27.15 and 27.16).
11. All communications must go to the Judge's secretary, **Ms T Nkuna** (TLNkuna@judiciary.org.za / (010) 494-8375), cite the case number and roll date, and be copied to all parties.
12. In all other respects the RCPD, in particular paragraphs 15 and 27, applies. The Judge may relax, vary or supplement any provision of this directive in a particular matter, on request or of the Judge's own accord.
