1. All matters will be heard in open court. The court in which the matters will be reflected on the roll which will be circulated daily.
2. Court & hearing will commence at 10:00 am
3. Introductions will be done in Court.
4. Removals and postponements will be called first. Practitioners must inform Mr Mahori Rmahori@judiciary.org.za before 12h00 the day before the hearing date if any matter will not proceed to avoid papers being read when it is unnecessary to do so.
5. Matters of the SIC thereafter will be called according to seniority.
6. A separate section must be created on Caselines named Special interlocutory which must have the following:
 - 7.1 Practice note
 - 7.2 Heads of argument
 - 7.3 Compliance affidavit
 - 7.4 SIC (TIC) order
 - 7.5 Proof of service of the SIC (TIC) order
7. Draft Orders to be uploaded onto Caselines. 1 hard copy of the court order will be required, another copy of Word should be prepared and emailed to the Judge's Registrar,
8. Complete details of the parties' representatives (including counsel) Acting Judge's name, date of hearing, number on the roll correct case number and the Court Number must be included in the draft.
9. Notices of Removals, postponements, Settlements must be brought to the attention of our office forthwith by a Widely Shared Note on the Caselines & emailed to Mr Mahori Rmahori@judiciary.org.za
