BEFORE THE HONOURABLE ACTING JUDGE MALULEKA FOR 08 JULY 2026

TO: ALL LEGAL PRACTITIONERS:

1. All matters will be heard in **OPEN COURT**, commencing at **10:00**. The court room will be reflected on the day roll.
2. The roll of **Wednesday, 08 July 2026** is attached at the end of the directives.
3. Introductions will be done in chambers 1.12 at 09:45.
4. Matters will be called numerically as per the court roll.
5. The Judge should be informed of any removals or postponements as soon as possible, through email and a widely shared note on Caselines.

6. Strict compliance with paragraph 7 of Practice Directive 1 of 2024 is required in terms of uploading documents on Caselines. Matters that do not comply may be removed or struck off from the roll.
7. Parties must upload their concise heads of argument by no later than 14h00 one day before the hearing date.
8. Parties must bring one hard copy of the Draft Order sought. Draft Orders must be uploaded on Caselines in MSWord and PDF format by no later than 14h00 one day before the hearing date.
9. Legal practitioners must ensure the draft order contains the correct date of hearing, correct number of the matter on the roll, correct case number, correct names of the parties, correct Acting Judge's surname and if there's any amendment made by manual script, such amendment must be initialled.
10. The draft order which is uploaded must further reflect the name of the counsel, the attorney and their respective email addresses and the disclaimer. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted.
11. Include the following Disclaimer: *This Order is made an Order of Court by the Judge whose name is reflected herein, duly stamped by the Registrar of the Court and is submitted electronically to the Parties/their legal representatives by email. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge or his/her secretary. The date of this Order is deemed to be the set down date.*
