DIRECTIVE FOR URGENT COURT MOTIONS BEFORE MKHABELA J

COMMENCING ON 25 MAY 2026

- [1] Kindly take note that all matters will be dealt with in open court commencing on **MONDAY 25 MAY 2026 at 9h00am (please check day roll for court room). Matters have been allocated as per the roll below and counsel need only appear on the day allocated.**
- [2] Introductions will be conducted at 08h45 in chamber 4.13.
- [3] Applications without practice note, will be struck from the roll. Parties must upload their practice note no later than **Friday, 22 May 2026 at 17h00..**
- [4] All cases **MUST** be uploaded on Caselines. If any problems are experienced, the Judge's Registrar should be contacted **TIMEOUSLY**.
- [4] A practice note must be filed on Caselines setting out the following:
- (a) The grounds for urgency;
 - (b) The nature of the application;
 - (c) The estimated duration of the matter;

- (d) If there is non-compliance with the JP's directives issued for the urgent court, the reasons for such deviation must be stipulated;
 - (e) Parties should ensure that a compliance declaration is uploaded onto Caseslines;
 - (f) Contact details of the legal practitioners, which must include both cellphone numbers and email addresses;
- [5] Where **no certificate of urgency has been filed and/or no practice note** has been filed **the matter will not be allocated unless good cause is shown for non-compliance** as per the issued directive.
- [6] Matters that are to be removed, postponed, or which have become settled – draft orders should be uploaded in both PDF and WORD format and are to be emailed to **XVilakazi@judiciary.org.za** **by no later than 17h00 Friday 22 May 2026.**
- [7] Draft orders should contain a disclaimer, indicating the date of hearing, Judges' names (i.e MKHABELA J), manner of hearing (i.e Court (NO.) or Microsoft Teams) and the name and details of Counsel/Practitioner and those of the instructing attorney.

- [8] **In all opposed matters heads of argument are to be filed by both parties before 12h00 on Saturday, 23 May 2026** Strict regard will be had to the grounds of urgency. **Please bring a hard copy of your heads of arguments.**

- [9] No piece-meal filing of affidavits will be allowed. Save with the leave of the Judge, no documents (save for practice notes and heads of argument) may be uploaded after 16h00 on Friday 22 May 2026.
- [10] If there is non-compliance with the practice directive, the matter will be struck from the roll, unless good cause is shown for non-compliance.
- [11] **An allocation does NOT mean that the matter is considered sufficiently urgent to be heard on the merits.** Submissions will need to be made regarding the grounds of urgency at the hearing.
