URGENT COURT DIRECTIVES:

1. MATTERS WILL BE HEARD ON MS TEAMS ON THE DATE AND TIME INDICATED NEXT TO EACH MATTER. PARTIES ARE ONLY REQUIRED TO PRESENT THEMSELVES DURING THE ALLOCATED DATE AND TIME.
2. Parties who have not yet uploaded their practice notes are reminded to do so prior to 12:00 on 27/07/2026.
3. If any matter settles or will not be proceeded with, the registrar of Nxumalo AJ must be informed thereof immediately upon it becoming clear that the matter has been settled or will not be proceeded with. Failure to do so may attract punitive costs orders.
4. Any document filed by any party after the roll closed must both be uploaded onto CaseLines and emailed to the Judge's registrar at the email address above. In addition, all such documents must (save in exceptional cases where this is impossible) be duly filed on CourtOnline before being uploaded.
5. Matters where no practice notes have been filed in accordance with the Practice Directives will not be entertained.
6. Applicants should upload a complete draft order in Word format and send a copy to the Judge's Registrar via email with the number it has been allocated on the top right corner.
7. Where it is indicated that a matter is not available on CaseLines, parties are directed to approach the Court Online Help Desk, located at Office 008 on the Ground Floor of the court building, for assistance in remedying the issue.
8. Once the matter has been made available on CaseLines, parties are directed to notify the Judge's Registrar by email, confirming that the issue has been resolved and that the matter is now accessible on CaseLines.
