5. Urgent Applications are intended to be called as set out hereunder, unless otherwise specifically arranged. Legal practitioners appearing in a particular matter so allocated, need only be present in Court on the date and at the time indicated alongside the specific matter.
6. Although it will be attempted to deal with matters as allocated, and whilst legal practitioners need only appear at the allocated dates and times, unless otherwise notified, a measure of flexibility may be required when the matters are to be heard in the Urgent Court and there may be other exigencies which intervene.
7. Matters may be struck for the want of a Practice Note, certificate of urgency and directive compliance affidavit unless there is good cause shown or exceptional circumstances prevail.
8. Due to time constraints imposed and the nature of urgent court proceedings, no consideration will be given to documents belatedly filed, save in exceptional circumstances. A satisfactory explanation must be incorporated in the Practice Note.
9. Please inform the Judge's secretary of any settlements or removals immediately.
