4. Draft orders must be duly completed and compliant (i.e. must contain the details of Counsel, reflect the date of the hearing and the Judge's particulars). Draft orders must be uploaded onto Caselines/Court Online in PDF and Word format and Counsel must bring a physical copy to the hearing in court. This order must be signature ready (i.e. remove the word "draft" from the tramlines, delete the "further and/or alternative relief" prayer etc.) Orders will be delivered by uploading same onto Caselines/Court Online. Parties with Court Online matters must follow the "7-Steps" to ensure that their Court Online matters bundle onto Caselines.
