PRACTICE DIRECTIVE: URGENT COURT APPLICATIONS

1. Mode of Hearings and Introductions

- Open Court Hearings: All allocated matters will be adjudicated by means of an oral hearing in open court.
- Court Introductions: Legal practitioners must note that all introductions are to be conducted strictly in open court.

2. Strict Enforcement of Urgency

- Establishment of Urgency: The allocation of a matter on the roll does not create a presumption that it is deemed sufficiently urgent.
- Merits of Urgency: Grounding arguments for urgency remains a prerequisite; legal practitioners must establish real and satisfactory urgency on the papers and in oral submissions before the merits of the application will be entertained.

3. Allocation of Matters

The urgent court roll is allocated between the presiding judges as follows:
